



# General Debate:

The Senate debated the following pros- The candidate is a "cool guy", handled all of his interview well, has confidence, and could be a great asset to BCSGA. He could be very engaging with students which is good to get student concerns. He has two letters of recommendation and experience with G.S.A, as well as the student government. But there have been multiple reports about feeling verbally harassed by the "God Guy", so it may not be biased.

The Senate debated the following cons- The candidate may become too social and not focus on the task at hand as he loves associating with people. He could also become biased due to too much interaction. There was a shown bias to the Free Speech area with the "God Guy". A remark made by him earlier about the "God Guy" indicates the sense that he may be internalizing comments versus just someone making comments about their opinion.

i. It was moved by Senator Galvez and seconded by Senator Sanchez to approve the appointment of Daron Smith for the position of BCSGA Senator.
