### 1. CALL MEETING TO ORDER\*

**2/3 quorum was met, thus a bonafide meeting was held.**

### 3. ADOPTION OF AGENDA

- a. It was moved by Senator Zavala and seconded by Senator Chavez to amend the agenda by striking out under item 3a. Adoption of Agenda "Tuesday" and replacing with "Monday".

### 6. INDIVIDUAL REPORTS

- a. Chair, *Senator Graves Sr.*: There was an email that I received this morning from Gina Hayden, GET Bus Correspondent. If you recall, we were trying to get the semester student bus passes. This email, as passed around to everyone, shows the need for a monthly pass for the students of Bakersfield College as it is used daily. They told me that they are getting more information, and will create a proposal. We should be hearing from them within the next couple of weeks. Additionally, with the Equity funding, this could definitely be supported by Bakersfield College. It would also address the parking because if more students take the bus, then it would clear up more space. We are still working on the vending

machine, and to have it placed on the campus. For the future, it will be best for all members to write roughly a four sentence paragraph for their reports, as Vice President Orozco wants all chairs to track the participation of all senators within committees and the Senate. There are also two pieces of paper with information about a transfer event, a dismissal workshop, and more workshops for all of us to partake in or to notify students about.

- b. *Senator Chavez*: I tried contacting Bright House to see if we could do discounts for students, so that they could have a cheaper wireless internet connection instead of doing a full package purchase. They have yet to return my calls. I have called them several times over Winter Break, but have still received nothing. I will be sending an email soon to see what can happen. I did mention before the pursuit of obtaining the filtrated water dispensers, specifically for the use of students' bottled water. I have already investigated the price and it runs from \$800 to \$1200. I did email the prices/quotes to the Vice President, and that way she can place them on an agenda for everyone to see.
- c. *Senator Zavala*: Glad to be on the advancement committee. I have a similar initiative to Senator Chavez's water filtration idea. The difference is that I would want to make it smaller and have it placed in the Campus Center. This leaves it to be in an open area where it can always be monitored, versus having it everywhere on campus, and allows us to test how it does as they are quite expensive.
- d. BCSGA Advisor, *Dr. Damania*: No report.

## 7. UNFINISHED BUSINESS

*Items listed in this agenda item have already been read or discussed once and thus are considered for approval of the committee*

- a. Black Caucus of California Community Colleges Leadership Conference.  
**Discussion:** This is set for February 19<sup>th</sup> through the 21<sup>st</sup> and a concrete tentative schedule has been finished. There is a \$110 registration fee. It covers the food, all information sessions, there will be a great grand speaker (Claud Anderson), and there will be a need of volunteers for tables/booths as well as getting people from one location to another. It was brought up that Ian, from the OSL production team, has a volunteer signup process that will go out towards all BC students, such that it is not entirely focused on BCSGA volunteers. This is a big event that will require more help than BCSGA volunteers alone. So far, registration has been low, but the goal is around 126 people from around 15 other community colleges. There is a large wait for the paper processing.
- b. Renegade Promise  
**Discussion:** This item was to be discussed at a later time as President Fowler has updated information, but is not present to inform the members.
- c. Planning of Community Hour  
**Discussion:** Community Hour is a student initiated and coordinated event on campus. There is still planning for who will be the speakers, and the date. It was requested for members to inform their classes and other students about the event once it is fully planned. Additionally, Senator Graves is looking to be more creative with the flyer process by using cards, as it is more efficient than whole sheets of paper. Senator Zavala opted to obtain the form to submit a request for flyers to the production team. A meeting is set for today with Vice President Orozco and another member of the Community Hour Committee, where the details will be hashed out for the next upcoming event. Once known, Senator Graves will inform all members.
- d. GET Bus Semester passes (w/Mrs. Hayden)  
**Discussion:** This was already addressed in the Individual Reports section for Senator Graves. It was reminded that there would be an update from GET in at most two weeks.
- e. Cold Sandwich Vendor Machine  
**Discussion:** This was also addressed in the Individual Reports section for Senator Graves. It was further addressed that it is just a waiting period now for Advisor Damania to let Senator Graves know what is the remainder of the process. Finances to purchase it have been allocated, the resources to obtain it have been provided, all paperwork has been submitted, and it may be that the last portion is just the final details with Eric Zavallah from Food Services.
- f. Resolutions Impact to BC Campus/Tobacco Free Campus  
**Discussion:** It was addressed that it would be the first item listed under Unfinished Business for the next meeting planned on February 1<sup>st</sup>. There will be individuals invited to the meeting who are interested in knowing more or wanting to participate in the process. Ms. Collier from Allied Health will be attending, and Aimee from the Renegade Rip. It was stressed that it is crucial for all members to attend the next meeting. It was discussed that the February 1<sup>st</sup> meeting will be at 10:15 a.m. and the meeting will be started around 10:20-ish a.m. This will provide (hopefully) ample time for all remaining members with a conflicting schedule to arrive.

g. “Assisting G’s Get a College Degree”

**Discussion:** Originally, the idea was “GED” instead of “College Degree”. It was changed due to the understanding that Bakersfield College is not in the business of provided GEDs, but actually degrees and certificates. Thus, it became the goal to create a pathway, a plan or list of resources for people who are in need or want to get a degree/classes. This list could also include the amount that it would generally cost, and transportation information, such that the only required action left of the person is their willpower to go for it. Senator Graves challenged the committee to come up with a plan or proposal to assist even the least educated individuals in acquiring a GED and then attending Bakersfield College. The proposal would need to address level of income needed to do this, transportation, and other challenges that they may face (such as records, addictions, and more). It was proposed to either also or instead make several workshops available to just about anyone.

h. Beautification Project update

**Discussion:** There is communication occurring with M&O, but Senator Galvez was the individual in charge of this item. As he is not present, the item was postponed to be addressed at a later time.

8. NEW BUSINESS

*Items listed in this agenda item have not already been read or discussed once and thus are considered for approval of the committee*

a. Hiring Armed Personnel on BC Campus/Active Shooter Prevention

**Discussion:** Cerro Coso Community College has a link on their website which is a tutorial on active shooter situations. Senator Graves asked all senators to view that tutorial. It may be available on the Bakersfield College website, but it was through the Cerro Coso website that it was found.

***\*\*It was moved by Senator Chavez and seconded by Senator Zavala to suspend the orders of the day and move to item 11. Adjournment, as well as postpone all remaining business items until the next meeting on February 1<sup>st</sup>, 2016.***

***Discussion: Senator Zavala needs to leave in order to attend his next class, and other members have prior commitments that they need to attend. As such, the absence of these members would disestablish quorum. Furthermore, the remaining items still have importance and need to be discussed, which should be addressed at the next meeting.***

9. ADJOURNMENT

a. It was moved by Senator Chavez and seconded by Senator Zavala to adjourn the meeting.

**Discussion:** No further discussion occurred.

The motion passed by majority vote of “aye” in voice vote. Senator Graves adjourned the meeting at 10:59 a.m.
