

Board Representatives by striking out under line 15 on page 2 "should relinquish all right to the ICC rep, should be held accountable by" and insert "should relinquish all rights as the ICC rep, and should be held accountable".

Discussion: The 'whereas' statement was incomplete and it needed clarification. There were no objections to the main motion, and the amendment passed with the votes tallied 7-0-0.

- ii. It was moved by Senator Herndon and seconded by Senator Zavala to amend S.B.##
 Mandating Attendance of I.C.C. Board Representatives Addendum A by striking out under section 10, item d., subsection 3, line item i2. "additionally" and insert "additional".

 Discussion: It was a basic grammar error.
 - There were no objections to the main motion, and the amendment passed with the votes tallied 7-0-0.
- iii. It was moved by Senator Zavala and seconded by Senator Herndon to amend S.B.##

 Mandating Attendance of I.C.C. Board Representatives Addendum A by striking out under section 10, item d., subsection 2, line item i. "missed two" and insert "two missed".

<u>Discussion:</u> It was an error due to awkward phrasing.

There were no objections to the main motion, and the amendment passed with the votes tallied 7-0-0.

b. It was moved by Senator Graves and seconded by Senator Nichelson to postpone the adoption of S.B. ## Mandating Attendance of I.C.C. Board Representatives.
