- Inaugural Speech given by the new President and Vice President: (Orozco) Thanks to all for coming today and for your support as the Bakersfield College Student Government Association in its 91st session. This past year, the student government built the foundation for our new government. We wrote and edited our new constitution with checks and balances. We made a political process that is similar to the way that our United States Government works. As we transition into the new term, we plan to build up with what the 90th session has already done. Now officers who are in our student government will have a first-time experience of politics on a basic level. Our officers will be trained with their jobs and be ready to help the students. That is one of our main goals this year: to help our students. Our constituents will not think of SGA as just strangers who sit in an office and spend their money. We want to be on campus with students, and want our SGA members to stand out not only on the Panorama campus, but the city of Bakersfield. The previous SGA set a pattern of constant community involvement. We thank them, and are proud of what they have done with the constitution and codes, which were written to make sure we'd advance. We can even do more now. (Fowler) There is a long list of qualities worth promoting. Bakersfield College is one the oldest community colleges in the country. Our alumni basis is strong, with such members as majority leader Kevin McCarthy, represented at the national leader. As well as President Christian said, Senate leader Jean Fuller at the state level. We have almost an overwhelming number of opportunities for scholarships, internships, and student employment. Recently, Brookings Institute ranked Bakersfield College 1st in California, and 6th in the nation for graduate career earning value. Community colleges often have a negative connotation in the world of collegiate academics. Bakersfield College actively works against the poor reputation.
