## 1. CALL MEETING TO ORDER\*

\*Vice President Orozco opened up interview debate\*

<u>Discussion:</u> It was expressed that it would be very beneficial to having another senator. Dialogue took place concerning his attributes to sensitivity to the deaf or in dealing with the pantry, and it was addressed that in the past BCSGA session he should dedication and that he definitely has a sensitive side due to working with kids often. Although Manuel had expressed he had time constraints for his upcoming school schedule, it was observed from former members that he is very good with time management and incredibly helpful.

The Senate asked the following questions:

<u>Discussion:</u> There was expressed concern that, seeing as how Kyle is a brand new student, he may need more time or experience on campus before participating in BCSGA. However, it was addressed that other senators had spent time on campus for a year before participating and still had so much to learn about BC. It was further addressed that Kyle showcased the willingness and assertiveness to not only learn a lot about BC, but to really help out.

## 14. APPOINTMENTS OF BCSGA OFFICERS
