  - 2) Three (3) SGA Senators
  - 3) One (1) Department Members

- 4) One (1) student-at-large (appointed by the Director of Student Life)
- 5) The Director of Student Life (ex-officio)

Dr. Damania will select from ICC representatives for student at large.

Director Hidalgo question on Category 1 Operating Funds #3. which states "For the purpose of this section, operating funds shall include college student media organizations, provided that a maximum of \$3,000 funding is available as start-up costs for the first year, with declining future requests outlined in a marketing and business plan submitted with the grant.

Dr. Damania: If a group of students want to build a club on campus that requires a lot of money (e.g. an independent newspaper or radio station), but can generate more money through advertisement. This sections allows

a club to receive funds to start up the StudOrg and eventually become self-

dependent and protected from the potential of interference from their

funding source.

funds.
