

I do agree with President Frazer that we should leave it there as a backup should we need it later down the road. If we stick it in something now, if something should come up, we are not going to have it later.

Dr. Damania: I think it is fine. Increasing the diversity activities, because it is something that is needed on campus to increase the amount of visibility. When we are talking about diversity, it is not just with student organizations we can fund with different departments. The Delano activities do a lot of diversity activities. I think that it is not a bad idea.
