Manager Dexter and I are working on a workshop for August, regarding club renewal/creation/empowerment. Around the time school starts. Working on Find Your Classroom activity at convocation, contacting StudOrgs to see if we can get volunteers.  
Advisor Ayala: Other campuses require orientation as a part of club registration. Lead a day retreat to be best equipped for the year. Host mandatory workshops throughout the year for development. Workshops on empowerment, leadership skills, renewal etc.
- d. Student Orgs Funding Manager, *Cecil Dexter*  
Nothing else to report.
- e. Director of Student Activities, *Isabel Saldivar*  
Nothing to report, just in recovery. Trying to start up an Athletics support club to ensure higher attendance and promote KVC stickers.

Nothing to report.
- g. KCCD Student Trustee, *Johanna Guzman*  
Trustee workshop at Riverside on August 4th-6th. Board meeting August 7th, at 1pm at Weill institute. Received invitation for leadership conference, Oct 9th-12th about engagement, advocacy, etc. with other Trustees. No board meeting in July. I encourage you all to attend the first board meeting, to see parliamentary procedure.

- a. DISCUSSION: Ideas for the Fall Semester and its Goals  
VP Anguiano: Changing the face of SGA to ensure everyone thinks positively of us, and not “snarky” or “passive aggressive.” It is more the idea of SGA, people may not feel secure enough.  
Manager Dexter: Maybe show more of a side that is visible, like cleanups and booths.  
Advisor Ayala: Things transition fast, so don’t think it is one specific person or session. Ensure you use your town halls to connect with your students, behave as though you always have an SGA polo. Ground goals with SMART method.  
VP Anguiano: Monthly tabling event with games, snacks to connect with them.  
Director Guzman: Doughnuts in the morning, supporting outside events.  
Pres Miranda: Wellness walks to ensure they are mentally and physically well, and that they can talk to us about anything.  
Advisor Ayala: Don’t overextend yourselves, to prevent burnout or doing things haphazardly.

VP Anguiano: President and I have ideas, but we want your thoughts as well.

Advisor Ayala: What do you want covered?  
VP Anguiano: New Brown Act meetings.
