1. CALL MEETING TO ORDER*

The meeting was called to order by Vice President Orozco at 6:00 p.m.

2. PLEDGE OF ALLEGIANCE*

The Senate conducted the Pledge of Allegiance.

3. ROLL CALL*

A two-thirds quorum must be established to hold a bonafide meeting

The following members were present: Vice President Orozco, Senator Chavez, Senator Herndon, Senator Partovi, Senator Roel, Senator Sanchez, Senator Zavala, and Senator Nichelson

The following members were absent: Senator Galvez, and Senator Graves

The following members were excused: Senator Philley

2/3 quorum was established, thus a bonafide meeting was able to be held.

4. ADOPTION OF AGENDA

The Senate will discuss this agenda and may choose to amend or edit the agenda. Upon conclusion of the discussion the Senate may choose to adopt the agenda.

a. It was moved by Senator Partovi and seconded by Senator Sanchez to adopt the agenda.

i. Discussion:

1. It was moved by Senator Sanchez and seconded by Senator Zavala to amend the agenda by inserting under line 5, item b. "The Senate will consider the adoption of the minutes from June 20, 2015".

<u>Discussion:</u> Vice President Orozco sought any objections to amending the agenda by inserting the aforementioned item. Seeing as there were no objections, the agenda was amended.

 - i. <u>Discussion:</u> There was no further discussion.

 The minutes from June 20, 2015 was put to a voice vote. There was a majority consensus of "Aye", with no indications of "Nay". The minutes from June 20, 2015 were adopted.

7. REPORTS OF BCSGA OFFICERS

- a. President, Clayton Fowler: I, along with other officers, attended the Student Leadership Conference in July meeting for SSCCC. It was very informative, and the methods learned will be implemented here to train all of the officers. BCSGA will be using CCCConfer, which is a new method of conference calling where it monitors who can talk at one time, and the whole meeting can be recorded. There was a new member elected to the Vice President of Governance and Policy position (which is similar to second in command for all of SSCCC). Additionally, verify the committees that you are participating on.
- b. Public Relations Manager, *Raquel Vega:* I will writing articles biweekly for the "Renegade Roundup", which is the newsletter that President Sonya Christian sends out to all faculty. The first article is currently being revised, but the later articles will include an individual highlight of all of the BCSGA officers. For any extracurricular activities that you participate in, please notify me so that those activities can also be highlighted on as mini articles throughout the year.
- BCSGA Advisor, Nicky Damania, Ph.D: Thanks to all who participated in today's photoshoot. There will be another photoshoot planned for August in order to get more outside photos sometime around the morning. Two volunteers are also needed for the Student Conduct Hearing Board. As the Conduct Officer of the campus, I need two officers that are willing and able to serve on the committee, where the students being reviewed could be dismissed or suspended from the campus. There are two big cases coming up, and the students being concerned could be someone you may or may not know. Further interview will be conducted for any officers interested in being on the committee, but August 10th may be the date of the case. Also looking for two volunteers for workshops held by the Office of Equity & Inclusion. It will be held on Monday, August 10th, and throughout the whole week, volunteers will be receiving intense trainings from 8-5 p.m. Volunteers will be paid and food is provided, but by participating you now become ambassadors for the campus. Please do not lose your BCSGA polo shirts, and you are not required to wear them all of the time. But do wear them for our big events. All officers should now have a nametag, and today is the last day to modify them. College Night will be held on September 14th from 5 p.m. to 8 p.m. Volunteers will be arriving at 4 p.m. Anyone else interested in dressing up as the mascot, or if you know anyone, the Office of Student Life is still looking for a mascot. The New Student Convocation is on August 20th from 5:30 p.m. to 8 p.m. All officers will be needed, and even needed before this time for the Director of Student Activities' event on that day. During the week of August 17th (Monday through Wednesday), there will be hour presentations given from faculty members. Two officers are needed to help with giving presentations, as well as assist in making presentations. On August 21st, there will be a mixer between with the student government from CSUB at the athletic center on their campus. On the week of August 14th, we will be having our own officer training.
