

a. It was opened by Vice President Orozco for the elections process of Geena Olague for the position of a BCSGA senator.

i. Introducation:

Geena Olague- I have a letter of recommendation from a public speaking professor that I took over this past summer, so that the Board may read it. I am an incoming freshman. I am really interested in the student government here, participated in ASB in high school, was heavily involved in extracurricular activities regarding politics, am a political science major and want to become a lawyer, completed the "We the People" program, and am heavily involved in music organizations.

ii. Interview:

How available are you during the week, as this position asks for a lot of time and dedication? -G/O: I am pretty available on Mondays and Wednesdays. I do not really stay late on campus on the other days of the week. I am not as heavily involved in music organizations this year, so I essentially have a lot of time this year.

Being on the SGA requires that you work with any and all departments and committees both within BCSGA and on campus, how do you feel about that?

-G/O: I love being involved, and especially being exposed to new things. I really do love working with people, and am very interested in it as I am a "people's person".

What does this position mean to you?

-G/O: I was very interested in this senator position as I really love politics. In last year's We the People program, we studied the constitution a lot, and my favorite aspect was Congress, such that I preferred the Senate over the House of Representatives. When I talked to Vice President Orozco, she mentioned the layout of the Senate, and I already knew that I was interested in this position.

Sometimes these positions can be very stressful. May you name a time under which the ball was dropped for a project and you were the leader of that project?

-G/O: I have been in several leaderships roles throughout high school. I am very responsible, and I do not mind taking the fall, or stepping into the leadership role, for someone else who could not handle a certain project given to them. In the instances where the ball was dropped, I just took a breather, explained what the situation was to the person I needed to report to, and find the most responsible/efficient way to handle the situation. If you were an animal, what kind of animal would you be?

-G/O: I would be a polar bear.

As you mentioned that you would be a polar bear, are there any specific attributes of that animal that apply to why you chose that animal?

-G/O: Polar bears are independent, are very protective of their cubs, and they take to the cold, extreme environment.

You indicated that you are very into politics, do you know any current political movements or legislation that is underway that applies to the academic realm for colleges?

-G/O: I am currently not as up-to-date with politics. But legislation that I am aware of that pertains to the college community right now is that Hilary Clinton and President Obama want junior colleges to be a sort-of debt free option for students.

What is your greatest while participating in ASB in high school?

-G/O: I was glad that I could always spread positivity when there were some very negative people within ASB, or those who would start rumors and whatnot, and amongst the student body.

For example, someone snaps at you one day very rudely for having a difficult day or several things to take care of, how do you handle that situation?

-G/O: I can understand as I have 5 siblings. I know how to stay a neutral person, how to address a person who may be feeling that way such that we address their problems, and really to just step back and acknowledge that it may not be my fault. It's really to talk to them and understand what is going on.

iii. General Debate:

It was expressed that it was beneficial that the candidate already has previous experience in student government, she had a good attitude, was friendly, and not afraid to talk. She handled the questions well, and even the questions that were confusing in the several ways that the questions was asked. The candidate seemed capable and knows how to approach problems. The con that was presented was that she seemed to have other obligations, and could be very busy with other extracurricular music activities and college classes. Being a freshman, she may not necessarily know what a college course load comprises of, but it was countered that she did seem very politically ambitious and willing to allocate her time as necessary.

iv. It was moved by Senator Graves and seconded by Senator Galvez to approve the appointment of Geena Olague for the position of BCSGA Senator.

Discussion: There was no further discussion.

President Orozco sought any objections to fast-tracking the election for Geena Olague. As there were no objections, the motion carried.

i. Discussion:

ii. Introductions:

-Senator Graves: Thank you for the nomination. I believe in this great college, and it is a place where you grow, find yourself, and help others do the same. I am motivated, dedicated, and definitely committed to growth and progression of Bakersfield College, as well as in growing the student body. Thank you again for the nomination.

iii. Interview:

Do you know what this committee encompasses, and what is the objective of this committee?

-F/G: I have a general idea for the mission statement of this committee. Regarding what this position carries, I believe it is to address issues with curriculum for the student body, to review to have the best professors and instructors, and that the campus itself is pushing student engagement, such that they feel welcomed on the campus.

Let's say that something happens, the "ball is dropped", and people start pointing fingers, how do you handle the situation.

-F/G: I would first review the scenario and take in all the facts, only focusing on how to resolve the issue and not taking away the talents of the person(s) being blamed, and make sure to encourage them while solving the issue.

If you could be any compound of elements on the periodic table, what would you be and why?

-F/G: I would be salt as it is in essentially everything of the earth, naturally in all of us, and it takes all of us for any program or organization to succeed.

Does this position work for your schedule?

-F/G: Considering that I have not looked at my schedule in depth, I am quite sure that I do have time to take on this position in conjunction with my Senator duties.

iv. General Debate:

It was expressed that Senator Graves is very dedicated, and willing to help students. Additionally, this position seems to suit him as it relates to what he wants to accomplish with his long term career goals that he indicated about when he first joined BCSGA. The candidate is very helpful, kind, and is regarded in a positive light by several faculty and administration members on campus, such that he would be beneficial to the committee as he is invested in the advancement of Bakersfield College. It was however suggested that Senator Graves does have a lot of time constraints since he involved heavily in other aspects on campus.

v. It was moved by Senator Roel and seconded by Senator Galvez to approve the nomination for the election of Senator Graves for the position of Chair on the Committee on Advancement of Bakersfield College.
