1. CALL MEETING TO ORDER*

The meeting was called to order by Manager Scott at 11:06 a.m.

2. ROLL CALL*

A two-thirds quorum must be established to hold a bonafide meeting

3. ADOPTION OF AGENDA

- a. It was moved by Pat Hawks and seconded by Paul Peterson to adopt the agenda for Friday, September 18th, 2015.

4. ADOPTION OF MINUTES

- a. It was moved by Angel Raygoza and seconded by Larry Rodriguez to table the adoption of the minutes from Friday, September 4th, 2015 until the following ICC meeting.

- a. Ian Juarez (from the Office of Student Life Production Team): There are two available bulletin boards for two clubs to use, but it is based on first come, first serve. Clubs are required to update it every two weeks; otherwise, it will be taken down. There are also posted dates and times for club meetings, so for clubs interested in letting students know when your meetings are, then let us know.

6. INDIVIDUAL REPORTS

- a. Student Organization Funding Manager, Manager Scott: The registration deadline for clubs has ended. Therefore, any clubs who do not have “FY16” indicated next to their club name on the BC website are not reregistered. There were only two clubs added to the list of reregistered clubs that have not yet been changed on the website however.
- b. BCSGA Advisor, *Dr. Damania (Interim Director)*: Do not hesitate to make sure that your club is reregistered. There are only 50 spots left for the Student Leadership Conference that is coming up soon. Also, clubs can apply to have the conference fees covered through the SOF grants. PLEASE spread the word about Homecoming, and rally up students, or even your clubs, to create competing teams. You do not have to only have a club team, but can also create your own individual team.

7. OLD BUSINESS

- a. Student Leadership Conference (Oct 3, 2015 at BC)
Discussion: It was discussed what the Student Leadership comprises of (i.e. the breakout sessions, the workshops, the keynote speakers, and the etiquette lunch tutorial provided), and the fee for attendance (\$10). - b. Appoints to BCSGA Committees and BC Participatory Committees
Discussion: Names were written down for all interested ICC members so that their contact information would be referred to BCSGA President Fowler, and to receive all available committee information.
- c. 2015 BC Homecoming (week of 10/12)
Discussion: It was discussed and shown how to navigate the Bakersfield College website in order to register teams for Homecoming, as well as to find all of the events for the entire Homecoming week. It was also asked of the council what ideas, or events, that they were interested in implementing for Homecoming week (and even for during the rest of the year). One idea that was presented by the Pre-Med Club was to host a run, or like a marathon, and to hold it on campus by using the track field or to create a course on campus.
- d. Gamers Night Out –Amend to Extra Life Event
Discussion: This event was changed to be the “Extra-Life” event instead of just Gamers Night Out for some members who originated the idea felt that it implied only certain kinds of gamers, and not necessarily a community event. It was also asked of council members to come up with team names, so that all students and the community can register under that team to participate in the Extra Life event run by CSUB in November and for the planned BC event during the Spring Semester.
- e. Fright Fest
Discussion: Criminology club indicated that they were planning to hold a special event for children, which is an event that serves as a safer way of trick or treating for all children in the community. Gender and Sexuality Awareness club indicated that they were planning to hold a dance event for all students.
- f. Feedback on Constitution Day
Discussion: It was expressed that Constitution day had a fairly good turnout for both students and clubs that were participating. The production team addressed all clubs to not make their signs look so rushed, and to prepare in advance signs for their table.

Discussion: Manager Scott explained to all members present the difference between the SOF grants that are available, and extensively explained how to apply for them, as well as the general restrictions that come for certain grants.
