

**College Council Report to FCDC
November 17 Meeting, 2017

A. President's Report

1. Technology Resources at BC (from Nov. 9 President's Report to the Board of Trustees)
 - Today, over 10,000 devices are connected to BC's wireless network at any given time during high traffic hours. That's a 400% increase since 2012
 - Only one technician has been added to Technology Support Services since 2012 to help with the demand for technology on all BC campuses (6 and counting).
2. Three Options for Fully Online College, presented to BOG (from Nov. 17 President's Report to College Council)
 - Option 1 would use an existing campus to create a statewide delivery system with campus faculty and campus instructional designers creating content. College employer partnerships would be used and new ones developed statewide.
 - Option.2 would use an existing community college district to host a consortium of colleges that opt-in to collaborate on FLOW, with faculty coming from the participating colleges. The host district would employ or contract with instructional designers as well as develop employer relationships.
 - Under option 3 a new community college district would be formed and operate under the CCCC which would hire leadership for the competency-based program. Selected faculty would work with the new district's instructional designers, and customize student services.

B. Committee Charge Revisions

1. Three committees revised and submitted their charges to College Council to be voted on: Assessment Committee, Curriculum Committee, and Equivalency Committee.

C. Guided Pathways: CTE & Strong Workforce Program

1. Strong Workforce is growing and offering our students tremendous services.
2. Strong Workforce presentations were given to CC from Commercial Music, Industrial Automation, Allied Health/Nursing, and Automotive Technology.
3. Strong Workforce is a great deal of technology (see President's Report 1 above).
