## 8. REPORTS OF BCSGA OFFICERS

- a. President, Clayton Fowler: I let the Executive Officers know about this already at our meeting last week, but I talked with President Christian about the GET safety issues, the BC shuttle program, and the issue about the international students. I asked if she had heard about other schools who were having a problem with their international students, or if they were having problems with their programs, and she informed me that she had not. I am also looking to build 2 advisory committees, and a memo will be sent out soon about it.
- b. Vice President, Janell Orogo: Becoming involved with the Delano campus is crucial, and we are looking to hold a meeting there soon. There were raised concerns in that some could not get transportation to attend a meeting held there if we did, but we could also hold a teleconference for those who must remain here in town. Also, if you know any students who are interested in joining BCSGA who are attending Delano, please let us know and urge them to apply. Additionally, I am hoping to start a club that urges students/clubs to go out to do community events, or volunteering, or that this will become a committee. Finally, please check your emails. I have sent out a reminder to all chairpersons that they need to hold meetings biweekly or weekly. But if you are a chairperson and have any questions, concerns, or need help, then let me know so that we can address it. For members of committees, if chairs are not holding meetings or are not letting me know about cancelling their meetings, then they will be removed.
- c. BCSGA Advisor, *Dr. Damania*: Homecoming went well and congratulations to all who won the Royalty Court. I have sent out a feedback review to all about Homecoming. Please submit it for all events that you attended as it helps us to better plan and organize events for next year. This week is the CCSAAA Conference, and all who are attending have completed the paperwork to attend. Members attending SSCCC must go to the Department on Legislative Affairs meeting on Thursday, as well as attend 2 meetings in advance of SSCCC. I would like to recognize Senator Zavala and Senator Graves for taking the initiative to fix, or investigate, the Art department issues and the Cafeteria issue. Finally, the Delano campus had 2 coordinators from us, and have a very active WECOMM club, which will be applying for a grant soon.

## 9. REPORT OF THE COMMITTEES\*

- a. Report from the Chair of the Committee on Academic Affairs, *Senator Roel*: I had all members attend the last meeting. Senator Zavala investigated the Art Department issue, and we are opening the table to be engaged more with the Deans, faculty, and staff. We have not had much to work with due to new people being placed into positions on campus. But the STEM department is looking to have us help them to publicize more about the new baccalaureate degree.
- b. Report from the Chair of the Committee on Advancement of Bakersfield College, *Senator Graves:*There is a concern about the number of people who are allowed to be riding on a GET bus. I spoke to the Operations Department Manager, and she indicated that she was unaware of the complaints lodged. Another key personnel apparently had their phone line disconnected, or that their voicemail was disconnected, for some time and had not received any complaints. I talked to the Public Relations Manager about having a safety notice publicized for both GET and GET riders to see/read. I spoke to Chef Eric about stretching the cafeteria hours. It was addressed that they could have an extra person, with a staff person required, to have the café open longer, but they work 10 hours already so it would be considered overtime. This would then have to be approved by the Head Supervisor, Anthony Culpepper. We looked into maybe prolonging their hours until 7:30 p.m. to cut half of the cost of keeping them there until 8 p.m., or to instead bring special vending machines to sell sandwiches. (It was recommended by President Fowler to contact Primavera in Equity & Inclusion to use Title V funds to do the student discounted bus passes, and also use the KVC to help pay for the

- fee. Additionally, to think about having a vendor come onto campus for that 1 hour slow as it helps to open a way to bring vendors onto campus.)
- **c.** Report from the Chair of the Committee on Finance, *Senator Sanchez:* Good job to all members for staying involved. The next meeting will be next week on Tuesday at 5 p.m.
- **d.** Report from the Chair of the Committee on Government Operations, *Senator Herndon:* There will be a meeting tomorrow at 4 p.m.

a. President Fowler opened up the appointment of Victoria Vargas for the position of BCSGA Justice Presentation:

President Fowler- Victoria Vargas has shown an interest in BCSGA, has been involved in many BCSGA and Office of Student Life events, and has worked in jobs and activities that have put herself in a leadership position.

Victoria Vargas- Hello, I want to be a justice to give the student body a voice, to have fun, and to become more involved on campus.

Interview:

What would you bring that benefits BCSGA?

V/V: I would bring hard work and dedication. I have volunteered a lot prior to applying for this position.

Have you been involved in any groups on campus?

V/V: I was President of the Geology Club, but later stepped down in acknowledging that my time availability and academic constraints were restricting me from fully giving to that position. I was also on the swim team, a BCSGA volunteer last year and this year, and am working in the Office of Equity & Inclusion.

What is your major?

V/V: I am majoring in Kinesiology and minoring in political science.

What is your schedule like?

V/V: I can make time if necessary, and it is pretty tight, but I am able to give as needed.

If you see an elderly woman trip over a tree stump, what would you do?

V/V: First off, I wouldn't laugh. I would worry if she is alright, and go check on her.

If you had a friend with you and they were laughing, what would you do?

V/V: I would ask them about what is wrong with them, tell them to hold my stuff, and go check on her.

What are your career goals and what high school did you attend?

V/V: I want to be a child physical therapist and I attended Highland High School.

A justice has the task to be fair and equitable, in knowing that you are close with some officers, how would you regard them in a way without being biased?

V/V: I would look at them in a light that is not of as a friend, but just as a person. I would just see them as another person, be unbiased of my own personal feelings towards them, and only take into account whatever details are at hand.

General Debate:

It was discussed by Senate members that the candidate is very kind, a hard worker, pretty fair in decision, and have interacted with the candidate on various occasions prior to the interview. It was addressed that the candidate does have a level of approach to issues, and has a good mind to give fair judicial review. Additionally, it was suggested that the candidate does not seem to have problem in making sure that a fair review is given regardless of having any close friendships with people who are concerned in a certain issue.

**b.** President Fowler opened up the appointment of Aracely Pulido for the position of BCSGA Justice *Presentation:* 

President Fowler: Aracely Pulido has a passion for representing students, has been in representative organizations before, and is a first year student.

Aracely Pulido: I was heavily involved in community service and activities in high school. I went to Arvin High School, and still am heavily involved in community service. My schedule is pretty available, where I range my classes from 8 to 12 or 1 p.m. daily.

Interview:

What makes you feel that you would be a good justice, or what can you bring that would benefit the Judicial Review Board?

-A/P: I can bring experience as I have leadership experience from being heavily involved in high school. I also did 'We the People' and am aware of reading, or analyzing, constitutions.

What are two strengths and two weaknesses that you have?

-A/P: My two strengths are that I am observant and determined, or persevering. My weaknesses are that I am fairly short, as it leads me to feel intimidated, and that I live fairly away in Arvin. What is your greatest leadership achievement?

-A/P: In being a big sister, I have great influence in having my sister become involved in her school, in extracurricular activities, and community service. As such, it has been my greatest achievement to influence her to take on opportunities that help her grow as a person.

What is an endeavor that you are proud to have faced that made you who you are?

-A/P: The endeavor would be financial dilemma. In having to rise through financial difficulty as I progressed through age, it helped to shape character and to find ways to overcome that difficulty to provide for various aspects of life.

What was your unit in 'We the People'?

-A/P: I was a part of Unit 1.

May you clarify what 'We the People' is?

-A/P: We the People is a competition among schools in the nation, state, and city, where high school students demonstrate their civic knowledge, and in analyze or interpret the constitution to be applied to various hearings.

This position also requires that you attend these Senate meetings, so would you have the time availability to do so, as well as transportation ability?

-A/P: Yes, I could make the time and arrange transportation.

General Debate:

It was addressed by Senate members that the candidate seemed very prepared, motivated, dedicated, and welcomed to get whatever she may need to get done. Many were impressed in the way the candidate presented herself as it was not expected according to her demeanor. In noticing that she is quiet but prepared, it should that the candidate likes to think before acting. It was also addressed that although the U.S. Constitution does not necessarily apply to this position, she is well qualified to be able to interpret and analyze COBRA, or the BCSGA constitution, in order to apply judgment to judicial review board cases. It was noted that the candidate had already read the COBRA and constitution before the interview with President Fowler. A point of clarification was made in that justices are *not* required to be at Senate meetings, and it is only on the will call if Parliamentarian Mann should be absent. The reason for doing so is that it keeps the justices neutral in cases about members of the association.

**a.** Senator Galvez: I talked to a constituent about recycling trash bins, and she thought that there would be more bins placed on campus that are outside. (He was referred to contact EJ from CSUB to ask about their recycling program and to have it implemented here at BC. Additionally, it was brought up

- to maybe have clubs customize the recycling cans or to contact clubs who do the recycling themselves.)
- **b.** Senator Sanchez: The Budget Committee will have a forum meeting on Monday at the Fireside room, and it will be facilitated by Professor Holmes.
- **c.** Senator Roel: As mentioned before, the new baccalaureate degree program needs an activity held to promote more about it. I am not sure as to what type of activity that they are anticipating. (She was redirected to contact Dean Rozell.)
- d. Senator Graves: I am needing more help in finding a direction to pursue the BC shuttle. Also, I attended the Good Neighbor Festival at the Martin Luther King Jr. Park, and I was able to promote BCSGA, AAMP, and BC as a whole. I was able to help inform them to programs that are available, and to invite to other initiatives going on. As part of "Feed the Hungry, Shower the Homeless", where our church went out to put showers in the parking lot, had several clothes donated in order to give away, and to also provide barber services.
- e. Senator Zavala: I met with Dean Rozell, and we are going to hold an event for the Bachelor's program in Industrial Automation. It is in progress where a panel discussion around lunch time will occur so that students can ask about the program, and it will be an RSVP event. I also investigated the art department clay issue. I was informed that there is a \$15 fee that all students have to pay, and that there is a way to rehydrate clay that is hardened, but I am still awaiting a response specifically as to why the students cannot use that particular clay that is available. The art department is also having problems with their budget as the budget never reflects the actual amount of students. I am also talked to students who are upset with MESA moving over to an area/facility that will be more accessible to the entire campus. The MESA program has a tutoring service and other initiatives that are available specifically only to MESA students, so this has been a currently rising problem.
- f. Senator Chavez: I received comments as well about MESA being shared with the rest of the campus, when it is not a club. It appears that faculty are treating MESA as if it were a club of some sort, where this is a program that is specific to students who apply to it. MESA helps STEM majors who are economically or academically disadvantaged, and the funding for the program is dissipating. Faculty see students in their who come to do homework, or students who are not a part of the program who are doing other things like watching movies or something, and they feel like they want to use it more for classrooms because the current use of the room isn't quite justified.
- **g.** Senator Herndon: I am on the curriculum committee, and they are in the process of reviewing/adding/removing classes, and making sure that the degree programs are updated.
- **h.** Senator Olague: I am seeking shoeboxes as I am partaking in a donation event, and I would greatly appreciate it. A constituent also expressed a concern for that there is a need for more trashcans.
- i. Senator Nichelson: I will bring up the MESA issue up at the next meeting when more information has been found out about what is going on, since the earlier provided explanation isn't substantiated but just from speculation.
- j. Vice President Orozco: The second CommUnity hOur is being held on November 4th from 12:45 p.m. to 1:45 p.m.
