

8. UNFINISHED BUSINESS

Items listed have already been discussed once and thus are considered for approval by the Body

a. Review of the: "Student Fee Handbook"

Discussion:

Director Zavala: I was given a list of items by Dr. Damania that he wished for us to review and discuss, including parking fees, transportation fees, and basic law and student fees. Last meeting Senator Montero-Garcia and myself went over the parking fees and transportation fees, because Senator Cooper was unable to attend the duration of the last meeting, we will quickly recap what was discussed. There is a possible \$50.00 charge that can be placed on parking permits, as well a cooperation between GET Bus and BC to allow student to ride free of charge on the GET Bus. The total cost for allowing BC students to ride for free would be around \$25,000.00, but these numbers have been inconsistent. Other topics of discussion ranged from the distribution of KVC stickers to allowing students to vote on whether they would want to be charged to allow free public transportation.

Senator Cooper. Perhaps we could work with SGA, and survey both KVC holder and non-KVC holders whether they would be willing to pay and optional transportation fee to ride free on the GET Bus.

Director Zavala: The input of the school is vital and this is something we will have to look further into before pursuing it. Because we only have so much time, let's discuss student parking fees a little more with the little time we have left. According to the student fee handbook, a fee of up to \$50.00 may be charged to staff and students to help in maintain the parking facilities and public safety per semester; for those who carpool and share-ride, those individuals pay only \$35.00 per semester. As the committee of Bakersfield College, we have the authority to change the prices as we see fit.

Senator Montero-Garcia: For the carpooling, we would have to devise a way to check if students are really ride-sharing with others, this would mean some sort of toll booth which would be detrimental during the morning hours.

Director Zavala: The student fee handbook also has a fee discount option for students who purchase their student body card; this translates to KVC holders being able to get a discount on the parking permits if we implement this and we could sell more KVC stickers in the coming semesters. Obviously, we would need to speak with the other departments like Public Safety, who get much of their funding from parking permits.

Senator Montero-Garcia: This, while beneficial, could be an obstacle to many students who would purchase both the parking pass and the KVC, in some cases they can only afford one or the other.

Senator Cooper. The current price of the parking pass is approximately \$35.00 to \$40.00, if we could somehow combine the two prices to equal \$40.00, it could further incentive student to purchase the sticker.

Director Zavala: Like I said earlier, this is something we would need to discuss with the other departments and Public Safety to see if this idea can come out. We will put this item in Consent Agenda for next meeting if we wish to speak on these items next meeting.

9. NEW BUSINESS

Discussion:

Director Zavala: We will be looking at the KVC sticker appeal for the semesters of 2010 fall, 2011 spring, 2012 fall, 2012 spring, 2013 spring, 2014 spring, 2015 spring, 2016 spring and 2016 fall. I did contact this student, I was not able to leave a voicemail, and email was also unsuccessful. Please discuss whether to approve some semesters or none at all.

Senator Montero-Garcia: Let's check where the student started purchasing the KVC stickers and where the gaps in between the semesters are, if any.

Senator Cooper: This student had 4 separate gaps between their semesters here at BC: 2011 fall, 2013 fall, 2014 fall and 2015 fall. I believe we should forgive the 2010 fall semester, 2011 spring. 2011 fall and spring 2012. As a new student it is difficult to get informed, but after three semesters they should be aware.

Senator Montero-Garcia: I think we should forgive the fall 2010 and spring 2011, but leave the rest unapproved.

Director Zavala: We will approve the semesters of 2010 fall and 2011 spring for the appeal.

Senator Montero-Garcia: There is only one gap between all of these semesters, I believe we could forgive the freshmen year, just as we did with the previous appeal.

Director Zavala: We will approve the semesters of 2010 spring and 2010 fall.

Senator Montero-Garcia: Unlike the other appeals, this one only has four semesters so we can appeal one semester if we please, and as a first time student, most aren't aware of all the aid they can find on campus.

Senator Cooper. Advertisement was also at its peak during these semesters, so it would be difficult to not know about the KVC sticker. In my honest opinion, deny all 4 semesters, but I agree that forgiving this student's first semester is fair.
