



### 7. APPOINTMENTS OF BCSGA OFFICERS

The Senate will consider the following nominations for an Association office. When the Senate has concluded its deliberations, the Senate may approve the nomination, reject the nomination, or take no action upon the nomination. Under BROWNACT, the meeting may not be closed.

- a. President Fowler opened up the appointment of Princess Herrera for the position of BCSGA Justice.
  - i. Introduction:

President Fowler- Princess Herrera is a current member of the Pre-Law Club, and I am appointing her to this position.

Princess Herrera- As soon as I heard about the opportunity, I was interested. I want to become a judge, and am looking to gain as much experience as possible to pursue my career goals. In being an ICC representative, I am familiar with the BCSGA process, and I think that this will be a great experience.

Interview:

What leadership position do you hold in Pre-Law, and how does that pertain to this position?

Being a justice requires that you make unbiased, impartial judgement, so how do you go about in being unbiased in topics that hold close to home?

It is understood that critical thinking will play a big part and the social ability that you have, but the question still remains in how do you do with setting aside personal feelings? Could you tell us about yourself?

Tell me about a time when you experienced a loss for doing something right, and how did you react?

Of course BCSGA is more than work and business, are you comfortable with going out and talking to a large group of people? This may encompass that you interact in activities. *General Debate:* 

It was clarified by Parliamentarian Mann that justices are not required to do what senators do. Their job description encompasses that the justices come together when there is an issue. It was addressed by a Senator that the candidate has a good background, believes that it would benefit her for career goals, and that she would do well in the position. Another Senator pointed out that the candidate might be too nervous, or that the position would be too much for her considering that she is a recent grad. It was then rebutted that the candidate is involved in Pre-Law, is an ICC representative, and doing the Pre-Law program. In being involved in these, it requires a certain mindset. Additionally, from doing well academically in high school and college, it shows the candidate is driven.

\*\*It was moved Senator Herndon and Senator Herndon to move the previous question. In seeing that there were no objections, the motion passed and general debate was ended\*\*

#### i. Introduction:

Madison Maner- Hello! This is my third semester here at Bakersfield College. I am interested in this position because of Geena Olague, and I decided to apply.

Interview:

What skills can you bring to BCSGA that would benefit the process?

Could you come up with a cheer for BCSGA?

What is your major and career plans?

Can you describe what else this position entails?

How are you with time management?

What organization are you a part of?

In conjunction with what was said about time management, there are 2 committees and 1 campus wide committee that you will be a part of, and activities that are planned around 11 to 2 p.m. Will you be able to fulfill this role?

What is a problem that you see on campus?

What is your perspective on bills and resolutions, and how do you feel about taking initiatives here on campus?

If you could be any fruit, which would you be and why?

General Debate:

It was discussed by a Senator in that the candidate does not have a lot of experience, but feel that she is open to learn. Another member indicated that they have worked well with her personally through another job. The candidate was very outgoing, cheerful, confident, and not afraid to ask for help. Another member indicated that she is always energetic, informed, makes people feel welcome and received, could bring some new life and energy from what is observed in class, but are unsure about whether or not she can handle the job. It was further stated by another senator from personal experience that the candidate could always deal with problems, is strong, and more than capable tow work under stress. Additionally, she is head leader when situations became stressful or unresolvable.

- **c.** President Fowler opened up the appointment of Geena Olague for the position of BCSGA Director of Student Activities.
  - i. Introduction:

President Fowler: As many of you know, and hopefully you do, this is Geena! Geena Olague: I hope that all of you know me from being a current senator. I applied for this position because I feel that I could enhance the position. I am very passionate about student government, and I believe that I can bring more to what is encompassed within

student leadership. (Geena gave a PowerPoint presentation. The PowerPoint presentation gave a thorough overview on what core concepts are to be considered to create events, how to create/implement successful events, perspective on leadership as a director, what will be accomplished/enhanced in the committee, what opportunities will arise from her leadership, the responsibilities expected from all members as being the director, and the reason for doing so.)

Interview:

All things have been planned, the event is underway, and Murphy's Law applies to where all things start to go wrong, and even constantly. How do you react under pressure, and how does your behavior tend to lean in order to remediate what is going on?

What are 2 strengths and 2 weaknesses?

How receptive are you to other ideas and opinions?

Are you familiar with what it now takes to run, or create, an event, and can you explain? What have you found to be difficult in being a leader of a team, and how did you deal with it?

An executive position is different from a senator's position. In being a senator for 3 months now, what did you learn as a senator that led you to feel that you were able to take on the position?

Can you give us an example where you ran into a problem and how you overcame it? Being an executive member takes up a lot of time, and this position takes even more time.

Will you be able to meeting the time constraints this requires?

How you would describe your leadership approach?

Can you give an example where you led a group to a goal, and that it meant to you as an accomplishment?

Being a Director of Student Activities, sometimes there are multiple tasks going on all at once. Can you multitask and provide an example?

Give us a specific example of a difficulty that you have experienced when working with this association and how did you handle it?

General Debate:

It was expressed by a Senator that the candidate is a very passionate, individual, and that once given an assignment, she can definitely handle it. But there was a concern in whether or not she can commit to it as she is dropping other commitments as she is the current Vice Chair of the Committee on Advancement. Another member also noted that she was quick to say what her weaknesses are, but not that she was strong in something else. Additionally, when asking about the protocol to coordinating events, she had not quite answered the question. Another member expressed that it is good that she wants to do the position and has the capacity/means to do so.
