## **Budget Decision Criteria**

Hiring a full-time faculty member aligns directly with the budget decision criteria of **student success**. The EMLS courses that a full-time faculty member teaches place students on a pathway toward a degree, certificate, transfer, and employment readiness.

Additionally, the reading, writing, and speaking courses that a full-time faculty member teaches develop the critical thinking skills necessary to help students "adjust to changing economic environments without having to continually come back to the college for retraining" (Bakersfield College Budget Decision Criteria). In fact, one of our program level outcomes is to "Evaluate and analyze expository essays and literature through the use of critical thinking techniques." This aligns directly with the institutional level outcome to "Think critically and evaluate sources and information for validity and usefulness," which aligns with the budget decision criteria.

Finally, the training and knowledge that students gain from our program are fundamental skills that are taught in each level of EMLS course. Part of the core mission of Bakersfield College is to "be able to continue to offer a range of courses" in all areas, including basic skills. A full-time faculty member in the EMLS Department will help Bakersfield College be true to its core mission.

## **College Strategic Goals**

Hiring a faculty member aligns directly with strategic goal 2.7, "Increase the percentage of transfer-level English completion in the first year." AB 705 mandates that students complete college level English within one year. The state chancellor's office has strongly recommended that state-wide ESL programs offer a college-level or transfer-level English course. The EMLS Department is in the process of writing a new college-level English course. The department plans to offer this course in fall 2019. However, if we do not have an additional full-time faculty member, we will not have enough faculty to teach the new college-level EMLS course in addition to the existing EMLS courses. See attached document "AA 18-41 AB 705 Initial Guidance Language for Credit ESL" for recommendation from state chancellor's office on transfer level ESL.
