1. CALL MEETING TO ORDER

The law does not permit any action to be taken, nor extended discussion of any items not on the agenda. The Senate may briefly respond to statements made or questions posed, however, for further information, please contact the BCSGA Vice President for the item of discussion to be placed on a future agenda. (Brown Act §54954.3)

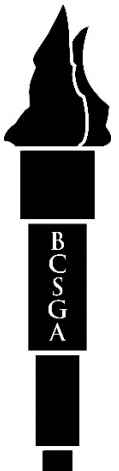
10. DIRECT REPORTS OF THE SENATE COMMITTEES*
