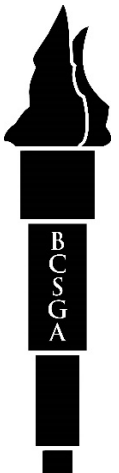
10. ELECTION OF ASSOCIATION OFFICERS
