1. CALL MEETING TO ORDER

2. PLEDGE OF ALLEGIANCE

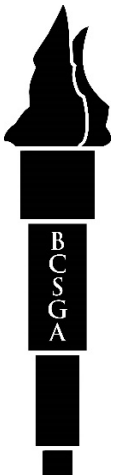
11. DIRECT REPORTS OF THE SENATE COMMITTEES*
