I. Approval of Agenda – Approved as presented.

II. New DE Coordinator & DE Committee Co-chair - "NewGuru" Debbie Lou!

- Committee members enthusiastically welcomed new Co-Chair and leader, Debbie Angeles.
- **III.** Canvas Administrator Debbie has taken over as PC Canvas Admin from BC.
- **IV.** Approval of Minutes March 9, 2023, minutes approved as read.

V. New Faculty Co-Chair 2023-24

- Joy Lawrence accepted the nomination as new faculty co-chair.
- Committee members unanimously elected Joy by anonymous ballot.
- Joy will take over the role effective May 30, 2023

VI. **CVC Consortium Update** (Debbie, Karen, & Joy)

- More colleges continue to get approved as Teaching Colleges, including State Center CC District.
- Karen has provided the required update to CVC to identify Debbie as our new CVC-OEI Project Lead, CMS Administrator, DE Coordinator, DE Committee Co-Chair, and Professional Development Coordinator.

VII. Student Services & Counseling Connection (Yolanda)

- PC Connection April 5th and 6th was successful and registered 117 new students for Summer 23 and 388 for Fall 23.
- New updates to the local PC Graduation Checklist led to need for updates to Ed Plans
- Absence of PHSC P112 offerings at PC continues to present a challenge for Elementary Teacher Education majors. Counselors are assisting PC students in finding the course offered

elsewhere online such as at Shasta College and others, or in-person at COS or Fresno City College so they can graduate and transfer.

VIII. **DE Administrative Procedures** (Joy)

- Academic Senate has asked the DE Committee to review and update our local twoannouncements-per-week policy, in particular for hybrid and synchronous classes, noting that Title 5 acknowledges live meetings as fulfilling the standard.
- Committee members considered various options, and ultimately raised no objections to this revision. Specific language will be developed at the next meeting.
- Updates to the policy will be noted in upcoming revisions to the Online Teaching Handbook and elsewhere.

IX. Online Teaching Conference – Funding available to attend (CVC + PC)

- Funding remains available for folks from PC to attend.
- Deadline is approaching for requesting funding and registering.

X. **ZTC Funding Opportunity** (Karen)

- PC online ZTC development funding application has been developed that invites applicants to note specifics of the identified course that will help prioritize applications based on how many state-identified goals the course meets.
- The form has been approved by the PC ZTC Taskforce and will be made available soon.

XI. DE Committee Charge Update (tabled)

XII. Distance Education Plan – Approved with adopted revisions.

- Committee members discussed suggested changes to the mission statement based on College Council feedback as well as broadening language related to science labs based on feedback from Academic Senate.
- Committee members agreed to applicable revisions as well as the change of "nursing" to be broader as "health careers" based on feedback from College Council.
- Revised DE Plan to be submitted to College Council directly after meeting for final review and approval at the April 17th meeting.

XIII. 2022-2023 POCR Program

- Updated Accessibility Requirements Stemming from changes to Title 5, CVC now requires all content in quality reviewed courses to be accessible (including optional and supplemental courses).
- Three courses of this year's cohort have been locally certified & submitted for badging.

- Revisions are ongoing for the rest.
- Certifications will be announced by graduation.
- Committee members agreed that the POCR Team should again assess this year's process for strengths, weaknesses, and potential updates as necessary for future years.
