Business Services

CFO. He briefed the Council that the new benefit numbers were received today; will work on this and report back; 3.46% to the medical cap increase.

P1 analysis update (see handout):

- May only give hold harmless+ COLA until May revised budget is received
- Property taxes is short
- Under funding on formula
- Some districts already spent the stated funding
- Column F total revenue is appointment only (unrestricted)

Chancellor Burke went over the different totals in our revenues listed with the Council. Question on DO budget regarding request for \$400,000 in on-going positions (new) at the DO. BC Academic Senate believes that the request did not follow the vetting process and does not agree with spending furthest away from students. The CFO commented that the new positions in question had been shared through the process at DO Admin Council, Chancellor's Cabinet, Consultation Council, and DWBC more than once. Chancellor reminded Council that the Board has taken action to move forward on the Human Resources and Business Services requested positions.

Educational Services

The District-wide Strategic Planning Committee is set to meet on the 29th of March to discuss:

- Aligning w/ state goals
- Draft plan to Board in April with final in May
- 5 of the 7 goals achieved; better than state average
- Clean up in data mort data
- Proposed to adopt vision for success goals; college can go above or slightly below
- Goal #3 number will drop due to AB705.

IR Director is working with college IR teams on data; equity coming soon.
