# Human Resources

The Vice Chancellor of Human Resources shared the Revised Fall 2019 Full-Time Faculty Obligation Number memorandum for the State Chancellor's Office as well as the Fall 2020 Projected Advance Full-Time Faculty Obligation Number memorandum. The P2 "reflected an error by which districts were apportioned funds for FTES above their growth targets."

The Board of Governors "will determine whether funds provided in the 2019 Budget Act are adequate to implement an increase in the Fall 2020 Faculty Obligation Number (FON)" at their November 2019 meeting, A full copy with exhibits of both memos were made available to the Council.

## **Business Services**

CFO Martin reported an update on the Student Centered Funding Formula (SCFF) as of August 2019. During a budget presentation by the State Chancellor's Office over the summer, information was shared about: 2018-19 Constrained TCR, 3.26% COLA, and Adopted Budget Apportionment. Due to the State Chancellor's Office not applying the deficit factor to the FON at P2, the projected FON numbers were over stated, which resulted in KCCD hiring more faculty than necessary to meet the FON.

No additional information will be provided to the districts until the P1 comes out in early spring 2020.
