 All three of the educational advisors are funded by categorical funds, all of them with VTEA funds in which 2 of them have been funded using VTEA funds for over 8 years, which exceeds the maximum allowed per Federal guidelines and the funding of position would now be considered supplanting. These positions much be converted to general funds.

- The Educational Advisors play a key role in the completion of the students in their assigned pathways. With the change in the funding model and focus on completion the Educational Advisor role are essential to ensure we get our students on the path and completed.

- CTE students account for approximately 50% of the student body, a failure to fill these positions will result in an inability to meet the needs of the CTE special population students.
- This failure could result in the college not meeting core indicators and metrics as mandated by federal guidelines, as well of the Workforce Innovation and Opportunity Act which would result in loss of
