CHANCELLOR'S OFFICE

I am writing to seek the assistance of IEPI for an issue we are experiencing at Bakersfield College.

Bakersfield College is known as a leader in the implementation of numerous state-wide initiatives, including Guided Pathways. The college's work to reconfigure its processes and support structures to anticipate and respond to student needs has resulted in a tremendous increase in the number of students receiving associate degrees and transferring. Thanks to strong leadership, execution, and use of data, enrollments at BC in 2022-23 have bounced back from the enrollment declines of the pandemic.

One critical area that BC seeks to improve further involves coordinating our efforts to close equity gaps in student achievement. The culture at BC is split between those who wholeheartedly endorse and support the goal of reducing equity gaps and those who question whether institutional resources should be directed toward efforts to improve the performance of historically disproportionately impacted at a greater rate than other groups.

Like many community colleges across the state, we are discussing the recent Title V changes and how to support Section 51201's statement on diversity. To further this work, I am writing to request IEPI PRT involvement in the following:

- 1) Governance committee structure, scope and development. We have an existing Equal Opportunity and Diversity Advisory Council that has historically struggled to define and execute its charge.
- 2) Strategies to address resistance to DEIA, particularly those who assert freedom of speech and freedom to dissent to justify their resistance to efforts to promote diversity, equity, inclusion, and accessibility.

An external group of respected leaders and experts in the measurement of student success and disproportionate impact would provide a natural focus for our efforts to create a unified culture and understanding of the critical necessity and appropriateness of closing equity gaps. A group of external experts would also provide a neutral starting place for this important conversation and could engage the college's formal and informal leadership sets in developing a constructive path to achieving the equity goals established in our 2022-2025 Student Equity Plan as well as a wider culture change that embraces equity, empathy, and meeting our students where they are.

We hope that you are able to support our efforts to improve equitable outcomes and campus climate at Bakersfield College with an implementation grant and a series of IEPI PRT visits. An ideal time for our first visit would be Spring 2023. I look forward to discussing this further with you.
