A BILL

ADOPTION OF THE BCSGA ANNUAL BUDGET (FY24)

1 *Whereas, one of the Bakersfield College's goal is "Student Success: Become an exemplary model of student success by*
2 *developing and implementing best practices";*

3 *Whereas, BCSGA is developing a more efficient and effective government to represent the student population at*
4 *Bakersfield College;*

5 *Whereas, BCSGA needs to be able to manage and expend in a fiscally responsible manner, while maintaining order for the*
6 *government to be more direct and strategically plan for future growth and ensuring transparency and accurate representation of the*
7 *budget;*

8 *Whereas, the direction of the BCSGA Budget is by dividing the total budget into three equal disbursements per areas under*
9 *BCSGA and to allocate funding for the Office of Student Life initiatives:*

10 *1. The Department of Finance account is for the Bakersfield College Student Government Association to be the*
11 *official voice for the students at Bakersfield College and to ensure that the students are represented in all matters*

1 *of the participatory governance. Through lobbying, advocacy, and student representation, the Association ensures a*
2 *supportive educational environment while promoting unity and cooperation with students, faculty, staff, and*
3 *administration. It is the intent of the Association to promote campus life, student involvement, and engagement. The*
4 *fiduciary expenditures rest in the managerial duties of the Director of Finance. The fiduciary controls rest in the*
5 *managerial duties of the BCSGA Department of Finance.*

6 *2. The Department of Student Activities account is to inspire and unite the Bakersfield College students through*
7 *programming derived from traditions, cultural diversity, large-scale entertainment, academia, and athletics. The*
8 *Department of Student Activities is a programming entity committed to providing the Bakersfield College community*
9 *with multicultural, social, recreational, educational, and entertaining programs in alignment with the BCSGA's*
10 *mission statement. The Department of Student Activities exists to enhance the BC experience by providing programs*
11 *to enhance the intellectual, intercultural, social, spiritual, physical, and recreational aspects of students' lives. The*
12 *Department of Student Activities provides a wide range of activities to students, consisting of new and different events*
13 *as well as traditional programs. The Department of Student Activities encourages student engagement on campus to*
14 *attract a diverse range of involvement and ideas, creativity in event planning, and excellence in event implementation*
15 *and leadership. The fiduciary expenditures rest in the managerial duties of the Director of Student Activities. The*
16 *fiduciary controls rest in the managerial duties of the Department of Student Activities.*

17 *3. The Department of Student Organizations account is to engage students in the development of their strengths,*
18 *skills, and leadership using student organizations as foundation by way of programs, workshops, conferences, and*
19 *leadership positions. The fiduciary expenditures rest in the managerial duties of the Director of Student*
20 *Organizations. The fiduciary controls rest in the managerial duties of the Department of Student Organizations.*

21 *4. The Office of Student Life account is to further develop new and sustain reoccurring initiatives and programs which*
22 *are directly under the supervision of the Office of Student Life. The foundation for these funds are vested in providing*
23 *for a professional KCCD Employee, student employment, and projects that are to enhance student life at Bakersfield*
24 *College. The fiduciary expenditures rest in the managerial duties of the BC Dean of Students. The fiduciary controls*
25 *rest in the managerial duties of the BC Office of Student Life.*

26 *Whereas, the funds from Student Representation will be used by BCSGA for regional, state, and national aff airs:*

27 *1. The Legislative Affairs account is accountable and transparent to inform the BC Student Body, the*
28 *Bakersfield community, where various laws are proposed and passed that affect our students and the community.*
29 *Legislative Affairs stays updated with all legislation that is pertinent to the BC Student Body, KCCD District,*
30 *Bakersfield City, Kern County, and the State of California, and Federal legislations and affairs. Legislative Affairs*

1 *is to be a representing voice of BC Students to the California Community College System. The fiduciary expenditures*
2 *rest in the managerial duties of the Director of Legislative Affairs. The fiduciary controls rest in the managerial duties*
3 *of the BCSGA Department of Legislative Affairs.*

4 *Whereas, the funds from the Campus Center Fee will be used by BCSGA for on-campus student center related expenses:*

5 *1. Education Code Section 76375 authorizes the student body government to approve expenditures of these funds for*
6 *the use of the student body center facility, operations, and programs. The fiduciary controls rest in the managerial*
7 *duties of the BCSGA Department of Finance or the Senate. The fiduciary expenditures rest in the managerial duties*
8 *of the BC Dean of Students. The BC Campus Center Building shall be deemed the Campus/ Student Center along*
9 *with the DST Lobby of the Delano Campus.*

10 *Be it enacted by the Senate of the Bakersfield College Student Government Association, the outlined model of the BCSGA*
11 *Annual Budget FY24 (Addendum A) is used as a guide and philosophy for all BCSGA expenditures to ensure transparency*
12 *and accuracy of the BCSGA planned expenditures;*

13 *Be it also enacted by the BCSGA that the Senate hereby adopts the BCSGA Annual Budget FY24 (Addendum A) for*
14 *expenditures;*

15 *Be it further enacted by the Senate of the Bakersfield College Student Government Association, the fiduciary controls and*
16 *expenditures of each section of the Annual Budget rests in the managerial duties of the respective departments and the Dean of*
17 *Students.*
