Under the Brown Act, the Senate may not close the meeting.

- b. Appointment of the Chairperson to the Senate Committee on Academics Affairs and Senate Pro-Tempore

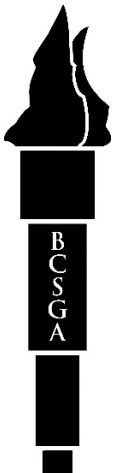
9. ELECTION OF ASSOCIATION OFFICERS
